Dear Parents,

While it may be hard to believe, it is already time to start planning for the new school year in September, and we hope your family will be returning to our school community next year. Attached to this letter you will find paperwork regarding re-registration for returning students and siblings who will be joining us for the first time as well as a tuition payment preference sheet.

Priority re-registration will run from today through Wednesday, January 27, 2010. We ask that your family print and return the attached Re-registration Form and Tuition Payment Preference form and fee to the school office by this date so that we are able to determine an accurate number of seats available to new registrants. Seats for returning students cannot be guaranteed if paperwork is returned after the above date.

First time registration for siblings of current students, including Kindergarten and Pre-School, is also starting today. If you have already called the office to advise us of a new sibling who will be entering school next year, a registration package is being sent home today in the family envelope. If you need a packet, please contact the school office immediately, and one will be sent home. These registration packets are also due back to school by January 27, 2010 to guarantee siblings a seat next year. Please note that kindergarten and first grade students must be 5 or 6 years old, respectively, by September 15th to enter those grades. Pre-School students also adhere to these dates for the three and four year old programs. Pre-School students must also be toilet trained.

Our general registration will open to new families on Wednesday, February 3rd. There will be an Open House that day from 9-10:45am which you are most welcome to attend if your schedule permits.

Tuition and Registration Fees Schedule for the 2010-2011 School Year

Registration Fees and Deposit

Minimum Deposit, non-refundable, per family \$250 (if more than 3 students in K through 8, then \$75 per student)

Registration Fee per child (included in deposit) \$ 75

Any portion of the minimum deposit in excess of the registration fee will be applied to the 2010-2011 tuition.

Tuition

MMR Kindergarten Tuition

Full Time	\$3,600
Morning Only	\$2,550 (this option will only exist if a minimum of 15 students enroll)

MMR Grades 1-8 Tuition

Standard Tuition Rate - Non-Participating Parishioners and Non-Parishioners. This rate will apply to any student whose family is not an MMR parishioner or whose family does not qualify as a Participating Parishioner based on contributions to MMR for the period 7/1/09 to 6/30/10 as defined below.

Participating Parishioner Tuition Rate. In order to qualify for participating parishioner tuition rate, a family must be active and registered at MMR. From a monetary standpoint only, participating parishioners contribute a minimum of \$15 per week or \$780 per year during the fiscal year period beginning 7/01/09 through 6/30/10 to collections retained by Mary, Mother of the Redeemer Parish via Weekly Collection envelopes. This criterion excludes donations remitted to the diocese by MMR such as Catholic Charities and other diocesan collections. *If the monetary criteria is not attained by June 30, 2010, the Non-Participating rates will be assessed.*

One Child	\$2,975
Two Children	\$5,090
Three or more Children	\$6,550

Payment Options. There are ONLY 3 options available.

1. Paid in full by check or cash before August 1, 2009. (This is the only option available to pay MMR directly. No multi-payment plans are collected by MMR.)
2. Paid in two installments through the FACTS automated tuition payment plan in August and December. A fee of \$15.00 per year is charged for this service (subject to change by FACTS).
3. Paid in ten monthly installments through the FACTS plan starting in August. A fee of \$38.00 per year is charged for this service (subject to change by FACTS).

Selection of Payment Option. The green **Tuition Payment Preference Form** enclosed must be filled out, signed by the financially responsible party and returned with the application and the required deposit. Applications **will not** be processed without this form. The **amount of tuition** will be determined by the parish based on the participating parishioner status as defined above. If you are currently using FACTS at MMR and wish to continue please check off the appropriate line on the form. No additional FACTS forms need to be completed and your payments will start at the new rate in August 2010. If you are not currently using FACTS and do not wish to pay in full before August 1, 2010, please check the appropriate FACTS box. Forms and instructions will be sent to you by the parish office.
